**Further processing:** monitoring events in front of cameras (live feed). Export and review of footage in cases of harmful events or suspicion of criminal offences to clarify the circumstances of the event and forward them only to the competent authorities, based on a justified and legal basis. The collected data are not used to perform automated decision-making or profiling of individuals. Data shall not be brought to a third country.

**Rights of individuals:** right to request access to personal data, correction or deletion of personal data or restriction of processing, right to object data processing, right to data portability. Rights may be exercised with a written request sent to the controller's address or by e-mail to the address gdpr@talum.si. The requests of individuals shall be processed in accordance with the applicable legislation.

**Legal protection**: a complaint or appeal may be filed against the conduct of the controller in relation to the protection of personal data with the Information Commissioner of the Republic of Slovenia.

Retention of footage: 1 year.
